**Evaluating the Role of Wood Products as Carbon Offsets.** After trees are harvested, their carbon storage capacities continue through wood products, contributing to US carbon sinks alongside living forests. Strong markets for wood products can encourage reforestation and prolong the duration of carbon storage, but challenges to the viability of these markets and calculating carbon credits, especially in the face of increased wildfire intensity and frequency, remain. Together, these experts will address critiques; examine the role of wood products in carbon accounting and offset markets; identify opportunities for crediting protocols; and clarify the role of wood products in reducing net emissions. The SGC recognizes FBH as an opportunity to accelerate progress toward California's housing production and affordability goals while reducing the environmental impacts associated with conventional residential construction. [This RFI](#) allows participants across the California FBH market to share insights on actionable strategies to address previously identified barriers to FBH deployment, such as zoning and other land use regulations, market conditions, supply chain dynamics, and access to financing. **Northeastern California Woody Feedstock Aggregation Pilot Project Entity Action and Long-term Objectives Plan.** Fall River RCD shares the final [Northeastern California Woody Feedstock Aggregation](#)

[Pilot Project Entity Action and Long-term Objectives Plan](#) (EAP). This Pilot Project was launched in 2022 to address barriers to biomass utilization through the creation of a biomass aggregation entity that supports biomass markets, incentivizes new wood processing infrastructure, and promotes forest management. As part of the project, the Fall River RCD team conducted outreach and engagement, assessed market capacity, and explored potential Joint Powers Authority (JPA) models for biomass aggregation. The team generated multiple reports analyzing market conditions, funding mechanisms, insurance options, and pricing strategies (reports available [here](#)). This information is synthesized in the [EAP](#) which establishes the foundation for the future activities and long-term goals and objectives of the RCD-led biomass management JPA, and makes specific recommendations for entity formation.
